Declaration of information obligation, in accordance with Article 33 REACH Regulation

Dear Sir or Madam,

Weishaupt SE is a manufacturer and a supplier under the REACH Regulation. No substances are released from these products and / or their packaging when used as intended and they are therefore not subject to required registration.

As a supplier of products, Weishaupt SE has a duty to inform its customers in accordance with Article 33 REACH Regulation (EC) No. 1907/2006.
